If any term or provision hereof is declared invalid by a court of competent jurisdiction, the remaining terms and provisions shall remain unimpaired and in full force. I acknowledge that I have read and understand this Release and that it shall be binding on me on behalf of myself and my child (if applicable) and my heirs.
